

## PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub: Procurement of Works mandating the Standard Tender Documents.

Read: 1. G.O.No.FD 06 PCL 2006, dated 21.3.2007.  
2. Proceedings dated 1.6.2007 held under the Chairmanship of Principal Secretary, PWD regarding implementation of Standard Tender Documents.

### Preamble

As per the G.O. dated 21.3.2007 cited at (1) above, the Standard Tender Documents for Procurement of Works given in Annexures-I to VII to the G.O.No.FD 09 PCL 2004(I), dated 6.8.2005 have been made mandatory and every "Procurement Entity" under the Government (as defined in Karnataka Transparency in Public Procurements Act, 1999) shall make use of these Standard Tender Documents w.e.f. 1.4.2007.

In the meeting dated 1.6.2007 read at (2) above, detailed discussions were held regarding implementation of Standard Tender Documents and the following issues relating to difficulties that are likely to encounter in the implementation of the Standard Tender Documents were discussed.

- Minimum financial turnover
- Satisfactory completion of similar works
- Owning of machinery
- Furnishing of 10% FSD
- Payments to be made within 90 days to the Contractor
- Design and Drawings part of agreement
- Bid capacity etc.,

Further, the following decisions were also taken


- a) The Chief Engineer, C & B (South) shall arrange to convene a meeting under the Chairmanship of Secretary, PWD with the representatives of other Departments, who deal with tenders for procurement and the issues and suggestions are to be compiled and to be submitted to the Standing Committee.
- (b) The Standing Committee to review the same and to submit detailed report along with recommendations to the Finance Department for favour of further action in the matter.
- c) The above process shall be complete with the time frame of three months
- (d) The Finance Department to be requested to defer the implementation of G.O.No.FD 06 PCL 2006, Bangalore, dated 21.3.2007 regarding adoption of STD till further orders.
