

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub:- Establishment of Karnataka State Highway Authority (KSHA) under Karnataka Highways Act, 1964 - Appointment of Members from Private Sector.

Read:- Government Order No.PWD 71 EAP 2001, Bangalore dated 15-3-2001.

PREAMBLE:-

In the Government Order cited under reference Karnataka State Highways Authority was established under Karnataka Highways Act 1964 under the Chairmanship of the Additional Chief Secretary to Government with 11 members, 6 from Government and 5 from Private Sector.

In the Government Order it was also stated that the Karnataka State Highway Authority (KSHA) would be an Advisory Body under Karnataka Highways Act 1964 to advise on planned development of Highways in the State of Karnataka.

In the above order the following were nominated as ex-officio members of the Karnataka State Highway Authority:
